## Section 1 – Community Games

<u>County Roscommon Community Games</u> provides various sporting activities and opportunities for young people through participation in areas, counties, regional/provincial events and through our national finals twice per year.

- Name: County Roscommon Community Games
- Sport: Multi Sport
- Location: Secretary Address (Declan Regan, Castlemore, Ballaghaderreen Co. Roscommon)
- Size: County Roscommon Community Games Executive Committee have 15 Adult Volunteers.
   County Roscommon Community Games has (approximate 5000 Children registered per year) children actively participating on an annual basis.
- Activities: The activities are divided into two categories individual and team.

**Individual events include**: Art, Model Making, Cycling, Gymnastics, Swimming, Athletics track and field events- specifically Shot Putt, Discus, Javelin, Hurdles, Ball Throw, Long Jump and Cycling.

**Team events include:** Badminton, Basketball, Camogie, Chess, Choir, Cross Country, Draughts, Debating, Futsal, Gaelic Football, Handball, Hurling, Mixed Distance Relay, Pitch and Putt, Rounders, Rubgy, Tag Rugby, Soccer (Indoor & Outdoor), Skittles, Spikeball, Table Tennis, Table Quiz, Pitch and Putt, Variety and Talent Events.

#### Section 2 - Principles to safeguard children from harm

County Roscommon Community Games is committed to safeguarding children and by working under the guidance of our *NGB* Safeguarding Policies volunteers, working with our young people throughout the County seek to create a safe environment for young people to grow and develop within sport. The following set of principles should be adhered to:

- **Importance of childhood** The importance of childhood should be understood and valued by everyone involved in sport.
- Needs of the child All children's sport experiences should be guided by what is best for children. This means that adults should have a basic understanding of the emotional, physical and personal needs of young people.
- Integrity in relationships Adults interacting with children in sport are in a position of trust and influence. They should always ensure that children are treated with integrity and respect, and the self-esteem of young people is enhanced.
- Fair Play All children's sport should be conducted in an atmosphere of fair play. The principles of fair play should always be emphasised, and organisers should give clear guidelines regarding acceptable standards of behaviour.



- **Quality atmosphere & ethos** Children's sport should be conducted in a safe, positive and encouraging atmosphere.
- **Competition** Competition is an essential element of sport and should be encouraged in an age-appropriate manner. A child centred ethos will help to ensure that competition and specialisation are kept in their appropriate place.
- Equality All children should be valued and treated in an equitable and fair manner regardless of ability, age, gender, religion, social and ethnic background or political persuasion.

#### Section 4 – Procedures

Our Child Safeguarding Statement has been prepared in accordance with the legislative requirements contained in the Children First Act 2015, Children's First: National Guidance for the Protection and Welfare of Children (2017), the Children (Northern Ireland) Order 1995, Tusla's Child Safeguarding: A Guide for Policy, Procedure and Practice.
